### **Project Context**

The Organisation for Economic Cooperation and Development (OECD) and European Commission aims at bridging the gap and bringing the worlds of vocational education and training (VET) and labour market closer together to address common challenges.

In Europe, the VET sector still has to go a long way in order to adjust VET to the changing and evolving demands of the labour market and the 'Agenda for new skills and jobs'. As OECD state in its key report "Vocational programmes are often rooted in education institutions, tending to develop their own dynamic, and can be too separated from the fast-changing world of modern economies".

### QSE-VET project main goal

The QSE-VET project will focus on promoting **evidence**-based approaches in VET, firstly on how to align VET programmes offered with the demand in the labour market and, secondly, how to adjust the skills being acquired and the qualifications offered in the curriculum to the occupational skills and qualifications being demanded by employers as the 21<sup>st</sup> century gets underway.

#### How does the QSE-VET project achieve it?

- ⇒ Develops guidelines and methods that will increase the effectiveness and efficiency of offered VET programmes.
- ⇒ Facilitates employers to have an active role in the assessment of students enrolled in VET programmes.



EBVET is <u>not</u> a <u>new</u> approach.

# **QSE-VET Project:** Objectives

The overall objective is to develop guidelines for VET authorities and VET providers concerning indicators for measuring the quality of acquired competences taking into account the requirements of the industry.

Quality standards will be described through guidelines and operational indicators, supported by concrete best practices. **The standards** will **facilitate the measurement of VET outcome** and will enable authorities to **introduce accountability for evidence-based vocational education and training (EBVET)**.

The QSE-VET project will support:

- $\Rightarrow$  The European Commission to further elaborate EQAVET towards policy decision with regards to evidence-based VET
- ⇒ VET-related authorities to create accountability policies and recommendations on effectiveness of VET with regards to employability and acquired competences
- ⇒ VET providers to develop better and more effective partnerships with the world of work in order to align their VET programs to the demands for competences by employers
- $\Rightarrow$  An increased attractiveness of VET, by providing the basis for educational pathways, better and more viable employability.
- $\Rightarrow$  The Prevention of early school leaving by introducing teaching styles more adapted to 21<sup>st</sup> Century skills in a learner-centred educational environment.

# What is performance-based and evidence-based approaches in VET?

### Performance-based approach

This approach is focused both on key competencies and domain-specific ones.

This is an approach to teaching and learning more often used in learning concrete skills than abstract learning.

Learners work on one competency at a time, which is likely a small component of a larger learning goal.

### **Evidence-based approach**

It is not a new approach. In USA, Australia, it started more than a decade ago.

The evidence-based approach for VET focuses on several operational indicators for measuring effectiveness of VET. However, indicators vary from country to country and depend on differences in culture, especially educational culture, awareness of employers and their sense of social responsibility.

- ⇒ Implementation and measurement of quality indicators of EB-VET with focus on:
  - Indicator 5. Placement rate in VET programmes
  - Indicator 6. Utilisation of acquired skills at the workplace
- ⇒ Best practices from Europe and internationally.
